TERMS OF BUSINESS

1. A booking will be deemed as knowledge and acceptance of our terms of business.
2. All work is undertaken either on your site or our clinic depending on your needs and subject to at least 6 appointments.
3. We accept telephone instructions for bookings. If you wish bookings to be made in writing only, or have any other specific requirements, then you should ensure your employees are aware of your company's policy and we are advised accordingly at the time of each booking.
4. If less than one clear working day's notice is given of a cancellation, we reserve the right to charge 50% of the booking value.
5. We reserve the right to charge for any candidate who is booked but does not attend or fails to bring with them specified photographic identification or proof of their National Insurance Number for Drug and Alcohol Screening only.
6. Any purchase orders, references or other information you wish to be put on any invoice or other documentation should be provided at the time of booking.
7. We charge 50% 14 days in advance for health surveillance work.
8. First Aid Training is payable in full 14 days in advance of the course - delegates names can be changed.
9. Mileage is charged at 40p a mile and overnight expenses are charged at cost.
10. We reserve the right to refuse to undertake any work if any invoices remain unpaid after 30 days.
11. We have an absolute right to withdraw any medical certificate or any other certifications issued by us if payment is not received within our terms of business.
12. Our terms are strictly 30 days from date of invoice. Pursuant to The Late Payment of Commercial Debts (Interest) Act 1998 and subsequent amendments, if payment is not received within 30 days we reserve the right to charge interest at the rate of 8% above base rate as set by The Bank of England.
